Conditions of Play for BNH Champ of Champ 2-4-2 Mixed Pairs

1. **General Conditions:** The “General Conditions of Play” as they are available on the Bowls North Harbour website will apply to this event to the extent, they are applicable.
2. **Play will commence by:** 10:00 am on Saturday 15th June 2024 for the first round of play. Players who are not scheduled to play in the first round must report by 12:00 pm on Saturday 15th June. On Sunday 16th June play will commence at 10:00 am.
3. **Greens:** This event will be played on artificial surface greens.
4. **Bowls:** Each player will play 4 bowls in each end in the 2-4-2 format.
5. **Time limit:** A time limit of 2 ½ hours will apply in all games apart from the final. The final will have no time limit. If the jack has been delivered before the end of the signalled time, the end will continue and if the end subsequently becomes dead it will be replayed.
6. **Ends:** Up to fourteen (14) ends will be played in each game subject to the time limit.
7. **Dead Ends:** If an end becomes dead it must be replayed in the same player sequence.
8. **Restricting the Movement of Players During Play:** In all games, players will only be allowed to walk up to the head under the following circumstances:

The player from each team who is playing the final two bowls of the end is allowed to visit the head before delivering their final bowl.
9. **Order of Play:** The order of play will be randomly drawn. All games will be played to find a winner of each game played. If after the required ends are completed, or the time limit is signalled, and the scores are equal, an extra end or ends will be played to decide the winner.
10. **Inclement Weather:** If weather forces abandonment of play before the completion of the event on day 2 then the balance of the games will be scheduled for a date to be advised.
11. **Prize Money Presentation:** The prize money will be paid to the club following the completion of the event.
12. **Event Entitlement:** The winning team will be entitled to enter the National Champion of Champion event being held in Bowls Hastings (Hawke’s Bay) from Friday 16th to Sunday 18th August 2024.
