TP opened the meeting at 6:30 pm

Bowls North Harbour Facilities Plan:

Faye Freeman reported on the updates and relevance of the BNH Facilities Plan which has been updated to include the recent changes to the Auckland City / AKTIVE funding model.

The changes were discussed, and the new funding model was clarified.

The key criteria for funding are:

- 1. A single project aligned with the BNH Facilities Plan.
- 2. Projects over \$1m only to be considered
- 3. Facilities only, not training, coaching, development etc.
- 4. Projects must demonstrate the return on investment:
- a. Targeting priority population, including disabled and multi-cultures, community, business house
- b. Growth of sport through increased participation
- 5. The project must be "shovel ready", including resource consents and partial funding
- The best strategic location (which would have the biggest impact on the sport)
 - i. Current options include:
 - 1. Orewa
 - 2. Sunnybrae
 - 3. Browns Bay
 - 4. Manly
 - 5. Hobsonville
- 7. Have options been considered to sell assets to fund new facilities
- 8. Consider projects that are underway

The next funding round is January 2025 with supported project and application to be made in November 2024.

The board thanks Faye Freeman for the extra work that she has done to understand the new funding model and to update the BNH Facilities plan.

The BNH Board must now review the projects that the clubs have identified and chose the one to support for the next funding round.

EVENTS HELD – The Winter Cup event for both men and women was completed on schedule in July although some days were affected by the weather. The results were –

Women – first Mairangi Bay Pearls, runner up Mairangi Bay Dolphins

Men – first Warkworth, runner-up Mairangi Bay

PENNANTS – Entries have now closed for this tournament with 7 entries in Division 1 and a further 25 entries in Division 2. Division 2 will be run in four sections and each section will be of equal rights with a winner and runner-up. The 7 entries per division will involve play over the three days allotted to this event and 6 entries per division will be played over two playing days.

NZ MASTERS – The organisation of this event remains a major effort for the Centre and the Match Committee. Additional resource is required to complete some of the tasks.

BOWLSHUB ENTRIES – This matter is being advanced with changes being made to the entry input so the payment is made direct to BNH rather than through BowlsHub. Changes are also being implemented to allow sides/teams to be entered and the names of the side/team entries being supplied at a later date.

It was noted that there is a need to have an Event Manager for the MASTERS and the CM is to look for volunteer assistance for this event.
